DISTINGUISHING FEATURES OF THE CLASS- ASSISTANT CIVIL ENGINEER: The work involves responsibility for performing professional engineering tasks of a moderately difficult caliber involving exercise of engineering judgment on a variety of projects. The employee may be in charge of projects in the field or of the design of projects in the office, or in some special phase of engineering or public works activities both in the field and office. Assignments are received from the County Highway Superintendent who outlines the scope of work to be performed, although the incumbent uses independent judgment in planning work details and making engineering decisions on routine problems. An incumbent gives advice, instruction and supervision on difficult technical problems to construction foremen and crew members. The incumbent does related work as required.
