JOB SUMMARY The work involves responsibility for leading, organizing and overseeing projects assigned by the Director of Community Mental Health. The individual will be responsible for facilitating oversight of the governance group associated with coalitions associated with Community Mental Health services. They will oversee implementation of the multiple initiatives of the coalitions. The work is performed directly under the general supervision of the Director of Community Mental Health Services with leeway allowed for the use of independent judgement in carrying out the details of work. The incumbent does related work as required as assigned.

MINIMUM QUALIFICATIONS: Either:

- A) Possession of a Master's degree in Mental Health, Social Work, Public Health, Public Health Education, Education, Community Health, Community Planning, or related field; or
- B) Possession of a Bachelor's degree in Mental Health, Social Work, Alcohol and Substance Abuse Studies, Human Services, Public Health, Public Health Education, Education, Community Health, Healthcare or Community Planning and two (2) years of experience in a related field; or
- C) Possession of an Associate's degree in Social Work, Alcohol and Substance Abuse studies, Human Services, Public Health, Public Health Education, Education, Healthcare, Community Health, Community Planning or related field and five (5) years of experience in related field; or
- D) An equivalent combination of training and experience as defined in A), B) and C) above.
