JOB SUMMARY: The work involves responsibility for performing semi-skilled maintenance, construction yard maintenance and repair work. The incumbent may work independently or assist a journeyman by performing less skilled duties. A construction yard person does not utilize the more skilled journeyman techniques for any considerable portion of the time, however, a working knowledge of one or more trade is necessary. The work involves coordination with multiple construction supervisors to prepare each crew with the appropriate materials needed for daily work to be completed. In addition, the work may involve the part time operation of a truck, automobile, or other automotive equipment. Work is performed under direct supervision. The incumbent does related work as required.

MINIMUM QUALIFICATIONS: Either:

- (a) Graduation from high school or possession of a high school equivalency diploma and three years of experience in general building construction, heavy construction, building trades work, inventory, or a closely related field; or
- (b) Four years of experience in general building construction, heavy construction, building trades work, inventory, or a closely related field; or
- (c) An equivalent combination of training and experience as defined in (a) and (b).

SPECIAL REQUIREMENT FOR ACCEPTANCE OF APPLICATION: Possession of appropriate class New York State Motor Vehicle Operator's License at time of appointment.
